# Driving Directions & Payment Information

## **Jewish Family and Children's Services (JFCS)**

13100 Wayzata Blvd. Minnetonka

Directions from the North:

Take either Hwy 169 or Hwy 100 South

Exit 394 West

Exit Plymouth Road and turn right

Turn right again at next stoplight

Directions from the South:

Take either Hwy 169 or Hwy 100 North

Exit 394 West

Exit Plymouth Road and turn right

Turn right again at next stoplight

## **GALAXIE LIBRARY**

14955 Galaxie Ave. Apple Valley

From North: Hwy 77 south. Hwy 77 becomes Cedar Ave. Go left onto 147th street. Turn right onto Galaxie Avenue.

From South: Cedar Avenue north to 150th street/County Road 42. Go left on Galaxie Ave. make a sharp left to stay on Galaxie Avenue.

From East: County Road 42 west. Go left onto Garret Avenue go left onto Galaxie Ave. make a sharp left to stay on Galaxie Avenue.

## **BROOKDALE LIBRARY**

6125 Shingle Creek Pkwy, Brooklyn Center

From East or West: I-94/I-694 north, exit on Shingle Creek Parkway. Turn south onto Shingle Creek Pkwy, go to John Martin Drive. Turn right into Library.

Form South: 100 north to John Martin Drive proceed to first left turn taking bridge back over Hwy 110. Follow JMD 3 blocks to Library/Services parking lot.

## **HARRIET TUBMAN CENTER EAST MAPLEWOOD**

2675 Larpenteur Ave. East. Maplewood

From I-94: Take Century Avenue (Hwy 120) exit. Go North 3 miles to Larpenteur Avenue. Turn left. Monastery Way is the first right. St. Paul's Monastery is straight ahead take an immediate left to go to the Tubman building.

From I-694: Take Century Avenue (Hwy 120) exit. Go South 4 miles to Benet Road, just before the light at Larpenteur Avenue. Turn right. St. Paul's Monastery is visible on the right. Turn left onto Monastery Way for the Tubman building. Take the second right off of Monastery Way to enter the Tubman parking lot.

From Hwy 36: Take Century Avenue (Hwy 120) exit. Go South 3 miles to Benet Road. Turn right. St. Paul's Monastery is on the right. Turn left onto Monastery Way for Tubman. Take the last right on Monastery Way to enter the Tubman parking lot.

## **SOUTHDALE LIBRARY**

7001 York Ave. South, Edina

From East or West: I-494 to the France Ave. exit, turn north onto France to west 70th Street, turn right onto 70th, go about 1 block. Library will be on your right.

From North or South: I-35W to Hwy 62 west, exit at Xerxes, turn South onto Xerxes. This becomes York Ave. Library at 70th street. Library will be on your left.

## **CHRYSALIS**

4432 Chicago Ave South, Minneapolis

From North or South: I-35W to 46th St. exit. Go east on 46th Street to Chicago Ave. Go left on Chicago Avenue about 1.5 blocks to 4432 Chicago.

From East or West: I-34 to I-35W South. I-35W to the 46th St. exit. Left on 46th street to Chicago Ave. Go left on Chicago Avenue about 1.5 blocks to 4432 Chicago.

## **SETON SERVICES/CATHOLIC CHARITIES**

1276 University Ave. West St. Paul

From the North or the East: 35E south to I-94 west. I-94 to the Hamline Ave exit. Turn right onto Hamline to University. Turn right again onto University for 1 block to Syndicate. 1276 is on the southeast corner. Turn right onto Syndicate and pull into the parking lot behind the building. Enter through the parking lot door.

From the South or the West: 35W north to I-94 east. I-94 to the Snelling Ave exit. Go straight across the intersection (on the frontage road) to Hamline Ave. Turn left (north) onto Hamline to University Ave, then turn right at University go 1 block to Syndicate. 1276 is on the southeast corner. Turn right onto Syndicate and pull into the parking lot behind the building. Enter through the parking lot door

From the North or South: Take I-35W to I-494, go east on I-494 to exit #3 (Portland/12th Ave). Stay on the frontage road to 12th Ave. Turn right (south) on 12th Ave, then right onto 80th St. Cornerstone is on the right.

From the East: Take I-494 to Exit #3 (Portland/12th Ave). Turn left (south) onto 12th Ave, then right onto 80th St. Cornerstone is on the right.

From the West: Take I-494 to Exit #3 (Portland/12th Ave). Stay on the frontage road to 12th Ave, turn right onto 12th Ave, then right onto 80th St. Cornerstone is on the right.

## **HARRIET TUBMAN CENTER WEST (MPLS)**

3111 First Ave S. Minneapolis

From the North or South:  
I-35 W to 36th/35th exit. Go west on 35th street. Take a right on 1st avenue. Tubman will be on the right side of the street a couple of blocks down.

From the East or West:  
I-94 to I-35W South. I-35W to the 36th/35th exit. Go west on 35<sup>th</sup> street. Take a right on 1st avenue. Tubman will be on the right side of the street a couple of blocks down

## **Payment and Registration Information**

For all sessions except Lavender Information Session there is a fee of \$20. Credit cards are only accepted at the Chrysalis location. For Lavender information session the fee is \$25 singles and \$45 for couples. All session are free for individuals who meet the low-income guidelines. You must call to determine eligibility.
