FROM OUR BOARD CHAIR AND CEO

Dear Friends and Supporters,

We're pleased to share our 2023 Community Impact Report with you! You'll find all the essential financial information, the report card on our progress toward our strategic plan goals and racial equity work, program highlights and photos of the year in review, the status of our Great Dreams Campaign, and a bit about what's on the horizon.

Here's an excerpt from a recent conversation we had about what stands out the most about the past year at Tubman.

Donnie: With a plethora of initiatives on the horizon, at our annual meeting in March 2023, my request to the board was concise, yet simple: "Read Up, Show Up, and Speak Up." This mantra has reverberated throughout Tubman, as evidenced by the participation reflected in the recent engagement surveys from both our board and staff. These sentiments also resonate with our clients and the broader community of supporters. "Read Up" underscores the importance of understanding the issues at hand and their significance. "Show Up" emphasizes active engagement, utilizing our energy and resources to effect meaningful change. And "Speak Up" embodies the courage to confront issues with truth, catalyzing transformation in our circumstances and the world around us.

Jen: I love that. One of the things I keep reflecting on is Brittany Delaney's poem she wrote and performed at last year's Starlight Soiree [see pages 8-9]. Her writing is such a powerful, raw, brilliant description of moving from fear to freedom. The lines that struck me that night, hearing it for the first time, and that have stayed with me ever since are, "And on the other side is life jackets/And i didn't need them because i couldn't swim/I needed them because i swim too well in troubled water." I think that learning to swim is a great metaphor for our prevention work, yet unlearning all the ways we grow numb or over-function just to survive is the intervention work. At Tubman, we know that both prevention and intervention are essential to our mission of safety, hope, and healing. And that sustaining and leading change is also vital — and every one of us can play a role in each of these things, individually and collectively.

We also talked about what's next for Tubman in the coming year. A few highlights to note: we're expanding our housing work by embedding our "housing first" approach across all programs, increasing staff to help navigate housing options, and providing additional rental assistance and aftercare services to residents leaving our shelter program. We're also working hard to meet the demand for addiction-informed mental health services, increase funding for our legal services to keep up with the high

demand in Ramsey County, and expanding our services at NorthStar Youth Outreach Center.

Thanks to our generous community, we're making tremendous progress in the Great Dreams Campaign. As of the end of March 2024, we've raised over \$7.56 million and are 89% to our goal of \$8.5 million by the end of 2025 to make additional investments in our places, programs, and people. We're ready to make necessary capital improvements when the funds are secured, and are currently raising the funds to establish Harriet's Haven for Pets onsite at Harriet Tubman Center East, in addition to recruiting foster volunteers — both of which mean that survivors will no longer have to choose between safety for themselves and their children, and safety for their pets. We still have about \$80,000 in matching funds from the Otto Bremer Trust, so now is a fantastic time to get involved by investing in the Great Dreams Campaign!

We have so much to be grateful for and excited about, not the least of which is being part of a world where survivors and supporters come together fueled by common purpose and vision: thriving people, healthy relationships, and peaceful communities.

Tubman serves people of all ages, genders, and cultural backgrounds who have experienced various forms of trauma, including relationship violence, sexual exploitation, mental health issues, addiction, and homelessness.

Our holistic and trauma-informed services are designed to provide a full continuum from violence prevention and crisis intervention to long-term stability and leadership development.

We serve the Greater Twin Cities metro area, particularly Hennepin, Ramsey, and Washington counties, with some clients coming from surrounding counties and greater Minnesota on their journeys to freedom.

VOLUNTEERS IN ACTION

In 2023, over 368 individuals and groups contributed more than 25,058 hours of volunteer service, including 140 interns and 69 pro bono attorneys. Their dedication and service allows Tubman to continue providing services which help light the path from fear to freedom. We are so grateful and honored for their commitment and work.

Tubman partners with more than 30 schools and colleges, 20 law enforcement agencies, and scores of community and culturally-specific service organizations to support the safety, hope, and healing of the thousands we serve every year.



ADVOCACY IN ACTION

Supporting our clients means addressing their immediate needs for safety and healing, as well as advocating for changes to the systems that create barriers to safety and healing for people experiencing violence and trauma.

We continue to partner with our coalition partners, including Violence Free Minnesota, Minnesota Coalition Against Sexual Assault, Metropolitan Alliance of Connected Communities, Youth Intervention Programs Association, Minnesota Coalition for the Homeless, and the Greater Twin Cities United Way, through testimony and advocacy as we seek changes in housing, economic justice, and violence prevention.

Additionally, Tubman received \$3.388M in cash bonding last year for infrastructure improvements to Harriet Tubman Center East such as a public elevator in our reception area, partial roof replacements, electrical upgrades, and completion of fire sprinkling code compliance. We thank our many legislative partners for recognizing the need for services such as ours in the community and supporting Tubman.

2023 SERVICE HIGHLIGHTS

Support in Crisis: **11,834 people in crisis** accessed support and resources by phone or in person.

Safety Plans: 5,969 people developed a safety plan by phone or in person.

Shelter & Housing: 244 adults and their 274 children received safety and support at our domestic violence shelter. Safe Journeys provided transitional housing and supportive services for 33 youth and their 7 children. Rapid rehousing programs helped 58 youth and adult heads of household and their 34 children secure and sustain housing in the community, with rental assistance and wrap-around services.

Legal Services: 3,105 clients received **12,869 services** including victim advocacy, legal information, advice or representation in Orders for Protection and family law, or helpline support on legal matters.

Mental & Chemical Health Services: **595 clients** accessed addictioninformed mental health support in our licensed outpatient clinic.

School-Based Prevention: 3,718 youth participated in our six week school-based violence prevention curriculum or attended a presentation on healthy relationships and violence prevention.

Youth Advocacy: 1,161 youth and young adults experiencing violence or exploitation received support and services in the community and in Tubman's housing and shelter programs.

Meeting Goals for Stability: **534 clients** addressed their wellness, financial, employment, education, or housing goals, individually or in workshops.

Community Education: 2,043 professionals, students, and community members learned about Tubman's services, relationship violence, exploitation, and other topics at community events and presentations.

A POEM FOR TUBMAN

It's 4 AM

I strap two little ones into car seats with an urgency that is so loud I swallow it's remnants leaving an orchestra of grief playing between the cage of my ribs

In the rearview mirror i catch the almond eyes of my children And i pull the strength from the souls beneath my feet to tilt the corners of my lips into a smile through the glare of the tears I don't dare let fall in front of them i tell them we are going on an adventure Never mind the uphill climb Or the gear i don't yet have Never mind the pitfalls Or the absence of rope

All i have is faith that i am making the best decision for them And an idea that i deserve happiness and safety in the places i close my eyes I deserve to wake up to something other than the fear of falling asleep too permanently at the hands of the sandman who decided my love was too bottom heavy

So he flipped me over to even me out To show me my place was everywhere Taking me apart piece by piece until I could fit tightly broken

I didn't have time to grab all of me I had to prioritize the most important part ...starting the list at my babies Carrying things by the arm full Knowing some will hit the ground And right now my only job is to make sure that its not them or me

This time Under the light of the moon I have to run I have to be like Harriet Find the underground tunnel in this house Make a map And follow it out

Never look back And whatever i leave let it be lost in the fire Let it burn the bridge back to me Let it uproot the nearby trees Let it take the straws we once grasped at Let the ash inhabit the air Let it make me unreachable by anyone who took advantage of the rickety pieces of wood here We arrive at the doors They are as perfect as they came into this world And I am embodiment of shambles I am made more of shame and guilt than blood and bone And i don't need to ask how i got here This journey That location Was and is muscle memory A reflex so deep in the generational tissue of my family That the first time i felt it I was as sore as lifetimes before me Ones so heavy it was hard to distinguish nature from nurture Mom from daughter Sister from Auntie Grandma from cousin Reflection from mirror This was as old as my bloodline Walking away was the only new addition exclusive release

I tell my babies we are camping These bunks are magic They help us transport wherever we'd like to go And the only rule to this improv bedtime story is that we can never go back the way we came I could see the excitement in their faces They have no clue why this happiness is perfectly placed in the most terrifying moment of our journey

And at this moment I don't know either I have never unpacked all of my belongings anywhere So the layers are both felt and lost on me I'm just trying to do the best i can to protect them from the same world that trauma got me in

I cry this time And they ask why So i tell them ...In this bedtime story These aren't tears This is me filling up the ocean so when we leave here We can swim in clear water So i can tell you where we are going And i can tell you what's coming next And i can see a future in the direction we are heading So at the fork in our future roads No matter how familiar I know not to go left We hear a knock at the door And on the other side is life jackets And i didn't need them because i couldn't swim I needed them because i swim too well in troubled water So i put one on I let the waves push me through because that is the only way out I'm too tired to keep fighting over flight So in this bedtime story I decide to imagine myself free Because even if this is still is the world of make believe In this story I can also believe in me

I keep hearing how children are resilient Far more than we realize But that is a story rooted in the idea of strength being earned through struggle And i don't want tough babies I don't want children who wear armor outside of made up stories I want my babies to know softness To be familiar with all 7 layers of their skin To be courageous enough to be vulnerable Because i am a child who came up learning to build steel walls around me To carry the bricks on my back and never ask for help lifting Life taught me to be tough And breaking taught me that hard surfaces have expiration dates

It's 10:30 AM

And this is the first time in a long time that my hours stood next to each other while I rested The sun doesn't hurt here And the evidence of railroads traveled are finally able to heal I hold my babies and i let their tears fall They are helping me fill up our ocean

The orchestra in my chest has changed the score to something more hopeful So I allow it to lull my children to sleep I allow myself to be peace Harriet would be proud I followed in her footsteps And because of this I am free

ANNUAL GOALS & IMPACT REPORT

In 2023, we created agency-wide goals for each of our four strategic directions: clients, community, culture, and capacity. Together, these goals guide our mission of safety, hope, and healing and create a pathway for serving our clients, engaging our staff, and supporting our community. On the next page you'll find examples of impact and progress toward our three year strategic plan goals.

Client Goal:

Assess, streamline, and redesign the initial points of access to services such as the 24/7 helpline, resource counseling, intake, walk-in support, reception, text lines, social media, NorthStar Youth Outreach Center, and Harriet's Closet.

Community Goal:

Broaden the community's understanding of what clients want and need, innovative approaches that work, and how to be part of the solutions.

Culture Goal:

Redesign the on-boarding process so that all employees feel valued, engaged, have a sense of belonging, and are prepared to do their best work.

Capacity Goal:

Recalibrate the level and scope of services provided (including serving fewer clients in some programs) in order to preserve quality outcomes given the current resources and environment.

Racial Equity Goals

Ensure professional development opportunities are equitable and make pathways to leadership more explicit.

Proactively practice ongoing efforts to recognize, support, and advocate for Indigenous people and nations through our Land Acknowledgment work.



Conduct staff training on assessing cultural competence with job candidates.

Explore offering additional staff affinity groups based on interest.

We remain grounded in integrating racial equity in all we do. In 2023, we accomplished four out of five of our goals, and through further review and feedback from staff, we determined not to move the fifth goal forward at this time.

MAKING AN IMPACT

LEGAL

- Actively built relationships with county commissioners and twelve cities to collaborate and partner to better serve clients
- Facilitated outreach to Native communities to better support clients in tribal court system
- Proposed and received funding for legal services from five different cities and Ramsey County
- Successfully piloted a Safety Project legal advice clinic for clients who are awaiting legal representation for Order for Protection hearings

SHELTER

- Implemented an innovative therapy and support group partnership reducing stigma by having therapists of color who specialize in serving victims of trauma who are Black, Indigenous, and People of Color (BIPOC)
- Reduced the number of beds by 10% to support ability to serve clients with more depth
- Held community events such as a Health Fair, Juneteenth, National Night Out, Domestic Violence Awareness Flag Raising to educate and partner with the community
- Staff helped facilitate a breakout session at the Brain Injury Alliance annual conference

YOUTH

- Received Homeless Youth Act funds for the first time in Tubman's history, which will be used to expand our footprint and operational services for youth at NorthStar Youth Outreach Center in Maplewood Mall
- Gathered input from clients, staff, and community partners to shape and innovate future services such as peer financial coaching, career exploration, and cocreation of art for Tubman's youth spaces
- Based on youth requests, Native artists were invited to our programs to teach jewelry making, helping clients connect to cultural identities and creating more connection and community in the process

CLINICAL

- With demand decreasing, we discontinued the Co-Occurring Disorders treatment program (COD) for substance abuse
- We continue to support chemical health needs through providing addictioninformed therapy services and by hiring more staff with dual licensures
- Provided psychoeducational group services to Minnesota Correctional Facilities for inmates preparing to discharge
- Continued focus on minimizing barriers to treatment through offering flexible ways to access services both online and in person

ADMINISTRATION & OPERATIONS

- Total rewards plan enhancements including increasing target hiring rate and giving a 5% increase for all staff to help offset cost of living
- Biennial Employee Engagement survey results improved in all three indices (engagement up 6 points, performance enablement up 1 point, work well up 7 points), and provided valuable feedback on opportunities for improvement
- Refresh of spaces at Harriet Tubman Center East including new carpeting, paint, window coverings, upgraded kitchenettes on residential floors, relocation of shelter/housing welcome desk for improved safety, a new group room for clients, and a new break room for staff

HOUSING

- Expanded recruitment networks, volunteer partnerships, including paid opportunities and engaged new collectives, ambassadors, and activist networks in event and leadership opportunities with the agency to better align client and community strengths and needs, maximizing more holistic support (improving advocacy, testifying, better understanding experiences)
- Deepened the neighborhood support networks for clients who are using our community housing programs
- More outreach and partnership with rec centers to connect people to our services in housing and youth

FINANCIALS

Tubman ended the 2023 fiscal year with a modest surplus. As of September 30, 2023, Tubman's net assets totaled \$14,764,950, of which \$6,975,868 (47%) are designated for future depreciation of property and equipment, \$2,006,250 (14%) are designated for repair and replacement, cash flow and staff compensation reserves, and \$2,255,086 (15%) is restricted for the Great Dreams Campaign.

While Tubman's sources of revenue remained stable, with a mix of government support, program service fees, and contributions; our funding from MN Office of Justice Programs for crime victim services (our largest government contract) remained flat at the same amount it's been since 2018. With funding not keeping pace with rising costs, at least one domestic violence program in the metro has closed and others may follow—which means that demand for Tubman's services will continue to rise. Our operating expenditures remained stable, allowing Tubman to make modest personnel investments necessary to attract and retain outstanding staff expertise to fuel our mission while serving approximately 18,400 people last year.





*Core Mission Support is the infrastructure that supports our services across the agency and assures the highest level of accountability to our clients, community, and funders. Included are the costs to maintain our facilities, security, technology and data management, financial accounting, etc. A total of 5.1% is used to secure the future resources that fuel our work.

The campaign committee, board and staff have been diligently working on inviting people to support the campaign, and invest in the places, people and programs of Tubman. HOPEtober was a success in large part because of a record-breaking 500 donors and a \$500,000 challenge match from the Otto Bremer Trust. As of this writing, we still have \$80,000 in matching funds, so don't miss the chance to double your impact with a gift to the Great Dreams Campaign.

As of March 2024, the Great Dreams Campaign has raised \$7.56M to date, 89% towards our goal of \$8.5M.

Current Projects

We have kicked off the planning process for the capital improvements at Harriet Tubman Center East and expect to begin several of the projects this year including new windows in the residence, the partial roof repair, and the new elevator which will increase accessibility and safety for our clients.

We also recently completed a feasibility study and plan to renovate the dormant commercial kitchen at Harriet Tubman Center East and create a social enterprise with multiple community partners. We are excited to pursue the viability of the Tubman Food Innovation Center in 2024.

Next up: raising \$1.1M for the construction and programming of Harriet's Haven for Pets.

Harriet's Haven for Pets will be the first onsite refuge for families fleeing violence with their pets in the Twin Cities.

Located at Harriet Tubman Center East in Maplewood, Harriet's Haven for Pets will be a full-service pet refuge that can house eight dogs and eight cats while their owners seek housing for themselves or other temporary care for pets. Harriet's Haven will provide round-the-clock monitoring, routine veterinary care, enrichment areas for families and pets to interact, and outdoor runs for exercise and relief. The space is designed to encourage pets and their families to maintain their bond and enhance healing for both humans and their pets, especially important for families that have endured trauma and violence.
